Reconsidered Goods, as a community convener around shared values and principles of environmental justice and creative reuse, is committed to using art as a force for positive change in the world.

LONG TERM CULTURAL EQUITY VISION

Reconsidered Goods (RG) will continue to review and adjust our practices to reflect our organizational values and, together with our reuse and arts community, will create a meaningful culture, structure, and embedded vision for diversity, equity, inclusion, and accessibility at our organization. We are committed to honoring and sharing our community's collective history and experiences through leadership, funding, programming, and engagement.

RG MISSION: to promote environmental awareness, community engagement, and creative expression through reuse, education, and the arts.

RG VISION: We imagine a world where nothing is used once nor thrown away but instead reused again and again.

DEFINITION OF CULTURAL EQUITY

Cultural equity embodies the values, policies, and practices that ensure that all people—including but not limited to those who have been historically underrepresented based on race/ethnicity, age, ability, sexual orientation, gender, gender identity, socioeconomic status, geography, citizenship status, or religion—are represented in the development of arts policy; the support of artists; the nurturing of accessible, thriving venues for expression; and the fair distribution of programmatic, financial, and informational resources.

- Encourage substantive learning to build cultural consciousness and proliferate pro-equity policies and practices by all of our constituencies and audiences.
- Improve the cultural leadership pipeline by creating and supporting programs and policies that foster leadership that reflects the diversity of our local community and society at large.
- Leverage the influence of the arts to advocate for policy changes that address environmental inequalities and promote sustainable practices at local, regional, and global levels.

PROMOTING CREATIVE REUSE AND ENVIRONMENTAL JUSTICE

To leverage the arts and creative enterprise to advocate for environmental justice, we strive to...

- Raise awareness by using the power of art created from found and donated objects to convey compelling messages that raise awareness about environmental issues, illustrating the urgency and importance of addressing environmental justice.
- Amplify voices by providing a platform for marginalized communities and artists, makers and creators from those communities, enabling them to share their stories and experiences
- Develop projects that educate and inform the public about the interconnectedness of environmental issues and the arts, emphasizing the social and economic impacts on communities.
- Facilitate collaboration with a goal of creating interdisciplinary initiatives that tackle environmental justice challenges holistically and through the lens of the creative disciplines.
- Promote sustainable practices and lead by example within the creative arts industries by adopting and promoting sustainable practices and minimizing the environmental impact of artistic programs, installations, and events.

CENTERING OUR ORGANIZATION, OUR COMMUNITY, AND THE WORLD

To ensure that our values lead the way, we strive to...

- Build partnerships and deepen collaboration to actively engage with organizations, artists, and communities that reflect the breadth of cultural diversity. By fostering these connections, we aim to co-create a space that respects, values, and integrates a multitude of cultures and identities.
